

Ironwood Homeowners Association Board Meeting Minutes

November 11th, 2025 6:30 PM

- Call to Order at 6:32. Quorum present
 - Board Members Present: Jeff Woodall (JW), JoEllen Bahnsen (JB), Mel Brown (MBr), Keith Palmgren (KP), Susan Parrent, and Suzann Reid (SR).
- Resident's Comments and Concerns
 - Kyle Bowles (XXXX Asbury Farms) - Fence Request
- President's Report: Jeff Woodall
 - JW nominated Susan Parrent to replace (now retired) Linda Rheeling on the Board. JB motioned to approve and MBr seconded. Approved 5-0.
- Vice President's Report
 - None
- Secretary's Report: Suzann Reid
 - Approval of Oct 14th minutes. MBr motioned to approve and KP seconded. Approved 6-0.
- Treasurer's Report: JoEllen Bahnsen
 - Beginning balance in checking account as of October 14, 2025 of \$ \$4,732.11. Total deposits of \$241.03 (interest from matured CD). Expenses paid totaled \$78.70. Ending balance in checking account as of November 11, 2025 of \$4,894.44.
 - There is \$15,000 in CDs at Busey. (One CD had matured and it was reinvested.)
 - Total checking + CD = \$19,894.44.
 - Discussed the need to replace Linda Rheeling as the second signature on checks since the by-laws require all checks to be signed by the Treasurer and another authorized individual. To be compliant with this, Suzann Reid will be the authorized individual.

 - LKM is expected to begin planting (trees, shrubs) this month while cleanup is still scheduled for December.
 - Lighting at the south end of the subdivision was repaired.
